- For English Full paper: It should be typed in Microsoft Word. The font should be "Times New Roman" with "12" size for matter,16 size in bold for title, 14 size in bold for main headings & 12 size in bold for sub-headings, having line spacing of
- 1.5 inch and one-inch custom margin on all sides & A4 Size Paper.
- For Hindi Full paper: It should be typed in Microsoft Word in "Unicode" with font size14 for content, 16 bold for title & 14 bold for headings, having line spacing of
- 1.5 inch and one-inch custom margin on all sides.
- A Uniform Style for Citation should be strictly adhered to while submitting full length papers.
- All in-text citations must be hyperlinked with the references (cross-reference). Use the word reference tab for cross-referencing and hyperlinking. We also recommend you use Mendeley or other referencing tools.
- Submit a brief profile of the author on the Word file/ doc file, which should not exceed more than one page, and try to keep it as brief as possible.
- Each article must be submitted with an impact statement of not more than 150 words.
- References/ bibliography must be serialized as 1, 2, ......

#### **Abstract**

Climate change represents one of the most pressing global challenges of the 21st century, posing complex legal and ethical dilemmas that transcend national borders. Rising global temperatures—1.1°C above pre-industrial levels as of 2023 according to the IPCC—are linked to increased frequency of extreme weather events, sea-level rise, and ecosystem disruptions, which in turn raise critical questions about accountability, equity, and justice. Legally, climate change has spurred a growing body of international and domestic litigation, with over 2,500 climate-related lawsuits filed globally as of 2024. Courts in several jurisdictions, including the Netherlands and Germany, have held governments accountable for failing to meet emissions targets, setting important precedents in climate jurisprudence.

The Paris Agreement (2015), legally binding on its 195 signatories, aims to limit global warming to well below 2°C. However, global emissions continue to rise, with CO<sub>2</sub> concentrations reaching 419 ppm in 2023—the highest in over 3 million years. Ethical concerns arise over the disproportionate impact on low-income nations and future generations. Africa, responsible for less than 4% of global emissions, faces some of the worst consequences, such as severe droughts and food insecurity, highlighting the principle of climate justice.

Moreover, corporations are increasingly scrutinized under Environmental, Social, and Governance (ESG) frameworks, facing both ethical obligations and legal exposure for contributing to climate degradation. The emergence of "climate disclosure" laws, such as the SEC's proposed climate risk rules in the U.S., marks a shift toward regulatory accountability.

This paper explores the evolving legal landscape and ethical frameworks surrounding climate change, analyzing key international agreements, litigation trends, and the role of corporate responsibility. It argues for a more robust integration of ethical imperatives into legal mechanisms to ensure both environmental protection and intergenerational equity, emphasizing the urgent need for enforceable global cooperation.
